## General Rules For All Shows

1. No unsportsmanlike conduct will be tolerated
2. There will be a two (2) minute gate call unless the show secretary has been notified of a tack change at the time of registration.
3. Show committee reserves the right to cancel, combine or change any classes
4. Registration for classes must be made at least two (2) classes in advance
5. The Pee Wee classes are for riders who have not mastered the canter or lope. These riders may not show in any other classes except Pee Wee and Walk-Trot
6. The judges decisions are final
7. It is a condition of entry that the CC Grange Fair Assoc and horse show committee will be held responsible for any accident that may occur to or be caused by a horse or individual at the show, or for any article that may be lost or stolen
8. Any questions pertaining to the operation of the show will be directed to the show committee and their decision is final
9. Negative coggins test required within 12 months of show date
10. Proof of age required as of January 1, 2010
11. Disqualifications do not place
12. Pee Wee and Mid-Penn Novice classes will be walk-trot only
13. Mid-Penn novice classes are for 1st and 2nd year riders only
14. AQHA novice classes are walk-trot-lope/canter
15. No cross entries in halter classes
16. Paybacks from all shows will be mailed to exhibitors
17. NO DOGS ALLOWED AT THE AUGUST 28 & 29 During CC Grange Fair SHOW

## General Information for All Shows

Shows will be held rain or shine!

All exhibitors will enter the grounds from Homan Lane, Gate 4 off Route 45

**From I-80:** take exit 161 (Bellefonte) Follow Route 220 south to Route 322 east and take the Old Fort (Rt 45) east exit. Follow Rt 45 east for approx 7 miles. Homan Lane entrance will be on the left before the John Deere Dealership.

**From Harrisburg:** Follow Rt 322 west towards State College. Take 144 north at Potters Mills. Turn left onto Rt 45 west at the light in Centre Hall intersection Rt 45/Rt 144. Go approximately 1/4 mile to horse show entrance (Gate 4—Homan Lane) on the right
